Privacy Notice

Introduction:

Panelman Engineering knows that you care how information about you is used and shared and we appreciate your trust in us to do that carefully and sensibly.

This notice describes the types of personal information that we may process about you, the purposes for which we use the personal information, the circumstances in which we may share the information and the steps that we take to safeguard the information to protect your privacy.

As used throughout this notice, the term "the Company", "us" or "we" refers to Panelman Engineering. By engaging with us, you are accepting and consenting to the practices described in this privacy notice.

Who we are:

Our core focus is on quality and delivery on time. Panelman manufactures and supplies safe and durable insulation products as well as competitive services.

When will we process your personal information:

In terms of the Protection of Personal Information Act (POPIA), the justification ground which we base our processing on consist out of the following:

Usage Data:

We may also process personal information on how the Service is accessed and used (“Usage Data”).
